Background

Section 284 (1), (2), (3), & (4) of the Municipal Act requires that on or before March 31st, the Treasurer shall provide to the Council of the Municipality an itemized statement on remuneration and expenses paid in the previous year to each member of Council in respect of his or her services as a member of Council or any other body, including a local board.

Further, the Treasurer is required to include each person appointed by the Municipality to serve as a member of any body, including local boards.

This report provides transparency and accountability of remuneration provided for Council and Board members to taxpayers and the general public in accordance with the Municipal Act requirements
