WHEREAS gardens and gardening contribute to the quality of life of our municipality, our climate action goals and create safe and healthy places where people can come together in the spirit of inclusivity and reconciliation;

WHEREAS the Year of the Garden 2022 celebrates the Centennial of Canada's horticulture sector and will highlight and celebrate the important contribution of gardeners, our local gardening organizations, horticultural professionals and local horticultural businesses which

contribute to garden culture and experience of our municipality;

WHEREAS gardens and gardening have helped us face the challenges of the COVID pandemic;
