The purpose and effect of the Amendment is to rezone the property from Residential Type Two (R2) Zone to Residential Type Two Exception Seven (R2-7) Zone and Residential Type Two Exception Eight (R2-8) Zone.

I will ask the Clerk for the method of notice for the public meeting.

The Clerk indicated that notice of tonight's public meeting was advertised in local media sources. Notice has been posted on the Town's website and notice was provided to property owners within a 120-metre radius of the subject property.

We will have a presentation by the Town Planner, following which there will be an opportunity for members of the public and Council to ask questions or provide comments. The Clerk will also accept written submissions. All submissions, written and oral, will be given consideration by the Council prior to any decision being made.

The Shelburne Diversity and Equity Committee has been informed of and is troubled by the recent incident that happened at Centre Dufferin District High School. We have yet to hear all the details, and want to be respectful to all parties involved, and to any ongoing investigation being conducted by the Police and the Upper Grand District School Board.

We want to take this opportunity to say that as a Committee we reject all forms of racism and discrimination. It is important that our schools remain safe, welcoming and inclusive for all of our students and staff. While significant progress has been made to strengthen our schools and community, we recognize that more work needs to be done.

We support an open and transparent investigation followed by meaningful action. Once the investigation is complete, we strongly recommend implementing a process to work collaboratively with the school, school board, students, families and other community partners to find a solution to the issues raised.
