Re: 2025 Pickin in the Park Grant Approval

As the original grant application was submitted, and approved for the continuation of Pickin in the Park in FiddlePark in 2025, the following revisions to the application are being requested. (Pickin in the Park is moving to the Shelburne Fairgrounds in 2025.)

- Assistance with “computer mapping” the Fairgrounds (as Denyse mentioned during a recent meeting).
- Usage of the parking lot between the CDRC and the Fairgrounds for parking, and entrance to the Fairgrounds. (no fencing required)
- Advertising on all town signage, website, and Social media pages, promoting Pickin in the Park, its new location, and the event features.
- Extension of Noise by-law until 12 midnight, for the duration of Pickin in the Park July 24-27, 2025
- Signage/information at Fiddlepark advising of location change
- Large garbage bags and elastics for plastic garbage bins
- Collection and disposal of garbage after the weekend
- 12 sets of road barricades
- Road signage (arrows/turn/ directions).
- Cutting of the grass within the Fairgrounds just prior to the July event.
- Spray paint and a spray marker (to mark campsites/roadways, etc)
