Tonight, we have a public meeting being held under Section 45(5) of the Planning Act to consider a minor variance application.

Minor variance application A21/05 is for property located at 301 Colonel Philips Drive.

The purpose and effect of the application is to request relief from Section 3.15.9. of Zoning By-law 38-2007 for parking requirements for a previously approved Site Plan application (SPA 17/02) for a commercial shopping centre / plaza development. The application is seeking relief from the parking regulations to permit a parking standard of 1 space per 19.1 square metres of floor area, whereas the Zoning By-law requires 1 space per 17 square metres of floor area for a shopping centre.

I will ask the Clerk for the method of notice for tonight's public meeting.

The Clerk indicated that notice of tonight's public meeting was advertised in local media sources, notice is posted on the Town's website and property owners with a 60-metre radius have received notification.

We will have a presentation by the Town Planner with a summary of written comments received, following which there will be an opportunity for Committee members and members of the public to ask questions or provide comments.

The minor variance is granted in accordance with the site plan provided to the Committee and attached hereto, only to grant relief from Section 3.15.9 Table 4: Parking Space Requirement Table which requires a Minimum Number of Off-Street Parking Spaces at the rate of 1 space per 17 square metres of gross floor area for a shopping centre, to permit a Minimum Number of Off-Street Parking Spaces provided at the rate of 1 space per 19 square metres of gross leasable area for 3 commercial buildings having a total combined gross floor area not exceeding 1,931 square metres, in accordance with an approved Site Plan.

A question was received from Lauren Dunlop:

1. Will you be cancelling Canada Day celebrations? Will you be putting the money you usually spend on fireworks towards something that could support Indigenous folks, or a town

- initiative to better follow the TRC or do better in terms of indigenous people.
- 2. Mayor Wade Mills said that not much action has taken yet towards the Truth and Reconciliation Commissions mini packs recommendations because they do not want to, "rush to implement policy in a knee-jerk or haphazard way." Since the TRC came out 6 years ago I would like to know how much longer will we have to wait to see changes? Reminding council, the indigenous people have been waiting over 150 years for changes. Specifically on the easy ones to implement such as recommendation number 57 where government is called upon to provide education to public servants on indigenous history, the UN Declaration of Indigenous Rights and many more.

Thank you for letting me submit my questions.

Mayor Mills responded:

With respect to Canada Day, the gravity of the situation requires a slightly more nuance question then simply do we cancel Canada Day or not, further discussion will continue under Council inquiries. I do agree that a typical event for Canada Day as in years past, complete with fireworks and celebratory fanfare would be tone deaf but also disrespectful and narrow minded, while we consider that thousands of our Indigenous brothers and sisters are hurting and grieving right now, with that in mind, July 1st this year can provide us with a unique opportunity, we can certainly still acknowledge, in perhaps a quieter, understated way, the good that this country has and still does represent, while also fully and properly acknowledging and reflecting upon the very deep and lasting short comings that we're still wrestling with, we also can consider what each of us can do to be better going forward. Chief Delorme of Cowessess First Nation has called on all Canadians to listen, learn, un-learn and start to heal, if the developments and discoveries over the last few weeks have shown us anything, it is that we do still have a long way to go and a lot to un-learn in this country. Canada Day must be something for all Canadians, any true celebration can

only be achieved, in my mind, when all Canadians are able to fully take part in that. This year, apart from quietly reflecting on what we do have to be thankful for, what we do have to be proud about as Canadians, we should spend the day trying to resolve in our own minds what each of us can do to listen, learn, un-learn, and start to heal.

In terms of the TRC reconciliation, I had the opportunity to share with Lauren the more notable steps this Council has taken, which are important ones, including the simple land acknowledgment, Shelburne was one of the very first municipalities in Dufferin County to do that and I am proud of the fact that Shelburne took the lead on that. We have also named several streets in the new Emerald Crossing development with Indigenous names and in recognition of Indigenous culture and heritage, specifically with respect to the TRC recommendations Lauren is right, these were issued about 6 years ago, during the first year of the last term of Council, 6 years is a long time to pass without any action taken. Lauren and anyone else who is watching tonight who has taken a keen interest will be happy to see there is a notice of motion that has been prepared and will be tabled later on in the agenda, we will wait and discuss that at the appropriate time.

A discussion ensued regarding safe travel for motorcycles and bicycles, liability on behalf of the Town, suggestion for change from speed humps to speed pylons to slow drivers, the Town uses speed pylons in front of Town Hall and to provide road closure for the Farmers Market, the need for a staff report with analysis in order to make an informed decision including consultation with EMS, parking impacts and costs associated, consultation with the Town's insurer to understand liabilities associated, staff recommended an immediate solution of allocating the entire community save and except the connecting link a reduction to 40 km, supplemented with the flashing speed signs, complemented with enforcement, speed hump traffic measures can be looked at as a supplemental approach, the flashing speed signs collect data that is being provided to the OPP for their review, the OPP have dedicated an officer to Shelburne specifically for speed enforcement and the need for further review.
