#### Recommendation

BE IT RESOLVED THAT Council receives report LS 2021-11 regarding request for fee waiver from Team Apex Real Estate be received for information;

AND THAT Council provide direction regarding the fee waiver request.

# Background

A request has been made to waive fees for the use of Brigands Soccer Fields for August 9<sup>th</sup>, August 23<sup>rd</sup>, September 13<sup>th</sup> and September 27<sup>th</sup>, 2021. The waiving of fees must be approved by Council.

On August 3<sup>rd</sup>, 2021, an email was sent to staff from Team Apex Real Estate requesting that the 2021 field use fees at Brigands Soccer field be waived. It was requested this be considered at the next Council meeting scheduled for August 23, 2021. A copy of the email is provided in Appendix 1.

Team Apex Real Estate was advised that their request would be considered at the August 23<sup>rd</sup>, 2021, meeting of Council. Staff needed to provide the estimated value of waiving of 2021 field rental fees and include this information to Council on the August 23<sup>rd</sup>, 2021, agenda.

### **Analysis**

Team Apex Real Estate is not a local Shelburne user group and has requested the use of Brigands soccer field for yoga in the park classes. Each class is estimated to be one hour, and participant numbers must be in compliance with Provincial COVID protocols. Participants are residents from Shelburne and the surrounding area, this will be a free event with a donation of a nonperishable food item for the Shepherds Cupboard foodbank.

The fitness program is 4 weeks, operating once per week, from August 9, 2021, to September 23<sup>rd</sup>, 2021,

Monday - 7 pm to 8pm

The rates and fees bylaw includes a charge for field rentals of \$19.65 per use.

#### **Financial**

The estimated value of the waiting of the park fee for Team Apex Real Estate is \$78.60 plus HST calculated at 19.65 per hour multiplied by 4.

In 2018, Council requested staff to develop a Waiving of Fees Guideline which was adopted February 12, 2018 and is attached as Appendix 2. Within the guidelines, there are several criteria identified to aid in responding to requests, including but not limited to the following:

- Maximum value of fees to be waived is \$500 per request requests with a value greater than \$500 must be referred to the Municipal Grant Funding Program
- Funding will not be provided to organizations that charge the public an admission, entrance or registration fee
- Fees will not be waived to support regular program costs, i.e., field rentals, etc.

The 2021 budgeted revenue for Park Rental Fees was set at \$8,000 (reduced from a \$16,000 budget in 2020 due to Covid). The amount collected to date is \$815.50.


#### **Park Fees Waived Request**

## **Guidelines for Requests to Waive Rental Fees**

### **Purpose**

The Waiving of Rental Fees Program is to provide financial relief to registered non-profit groups, organizations (an organized body of people with a particular purpose, such as a business, society or association) and individuals who can demonstrate that they can deliver programs, events or activities, that the Town or its organizations already supported by the Town, would not normally provide and that could benefit all residents of Shelburne.

### **Objective**

To provide an objective means for responding to requests for waiving of rental fees from registered not-for-profit community organizations, individuals or groups and establishing criteria guidelines and a formal request process to follow.

#### Criteria

These criteria have been established to aid in responding to not-for-profit groups, organizations or individuals requesting fees to be waived. However, meeting all criteria does not guarantee that fees will be waived.

- Only requests from registered not-for-profit groups, organizations and individuals will be considered
- Organizations must be not-for-profit; service oriented; and structured so as to confer no benefits to its members
- Maximum value of fees to be waived is \$500 per request
   requests with a value greater
   than \$500 must be referred to the Municipal Grant Funding Program
- Fees will not normally be waived on a retroactive basis, e.g., after an event has occurred
- The request must address a community need, respond to an under-serviced demand, or contribute to the Town's overall positive image
- Benefit to the community/public good is demonstrated
- Event/Activity/Function must occur within the Town boundaries
- Funding will not be provided to organizations that charge the public an admission, entrance or registration fee
- Fees will not be waived to support regular program costs, i.e. field rentals, etc.
- Funding will not be provided to organizations that have an overdue amount owing to the Town

#### **Process**
