Mayor Mills - Tonight, we have a public meeting being held under Section 53 of the Planning Act to consider a consent application.

Consent application B21/03 is for property located at 485387 30th Sideroad in the Town of Shelburne.

The purpose and effect of the application is to create an easement to allow a water pipeline to run through the subject land to the abutting property to the west.

The Committee, having regard to those matters under subsection 51(24) of the Planning Act R.S.O. 1990, c.P.13., as amended, resolves to grant provisional consent subject to the following conditions being fulfilled:

- That the Secretary-Treasurer's Certificate under subsection 53(42) of the Planning Act R.S.O. 1990, c.P.13, as amended, shall be issued and the Secretary-Treasurer's fee be paid;
- That approval of the easement documents and the draft reference plan shall be obtained at the Committee of Adjustment office (Town of Shelburne) and the required number of prints (3) of the resultant deposited reference plan shall be received; and,
- 3. That the conditions are to be fulfilled and the consent is to be finalized on or before one year form the date of the issuance of the Committee's notice of decision.
