1. 2022 Draft Budget Public Presentation by the Director of Financial Services/Treasurer.

The Director of Financial Services/Treasurer presented the public budget presentation.

Mayor Mills called for public questions and comments.

Len Guchardi - Questioned the extra costs incurred for Bylaw Enforcement with the hiring of a security firm for winter parking enforcement - were those anticipated costs or unexpected costs?

Mayor Mills - It certainly did not come as a surprise, the approach that has been taken in hiring a private security outfit to enforce winter parking is a short-term mechanism, it was always seen that way when the decision was made, one of the new positions that is accounted for in this budget is a second Junior Bylaw Officer, as part of the transition to OPP the expectation was there, bylaw issues relate to bylaw enforcement as opposed to police enforcement, that goes in hand in hand with the expectation we had when it was decided to transition to the OPP, the first couple of years would see a slight increase in terms of costs, over the long run those costs will be reduced substantially which can be seen in this budget when it's projected out to 2025, that particular page of the page panned out to 2025 shows significant anticipated savings.

Further discussion continued regarding the cost of snow removal for the transit shelters in Orangeville, staff noted and confirmed that snow removal for the transit shelters in Orangeville is approximately \$1000 and are being covered by Grey County as part of their transit service, the amount included in the draft budget was based on snow clearing and maintenance for transit shelters in Shelburne, the amount was estimated at \$8,000, the adjustment to be made is to reduce the amount being transferred from the tax stabilization reserve in the amount of \$8,000.

WHEREAS with the rising numbers of covid positive cases across both the province and country and the increased demand/requirement for antigen testing to safely return to the workforce regardless of vaccination status;

AND WHEREAS to provide to the citizens the understanding that their government is working for their health and not profits, by assisting citizens that do not have access to employment provided tests or the privilege of paid sick days while complying with recommendations to quarantine upon symptoms and or positive test results thus not receiving income for quarantine periods and paying for antigen testing to return to work would create further financial hardship; BE IT RESOLVED THAT Shelburne Town Council calls on the Provincial and Federal Government to work together to implement a universal rapid antigen test cost for the retail sector both province and nationwide, and that this cost reflect the current economic state and be as cost efficient as possible so that profits are not made off the health of Canadian citizens, and that this be implemented immediately to lessen the financial burden of acquiring rapid antigen tests;

AND THAT staff be directed to forward a copy of this resolution to all Ontario Municipalities, Wellington Dufferin Guelph Public Health, the Minister of Health Christine Elliott, Dufferin MPP Sylvia Jones, Dufferin MP Kyle Seeback, Premier Doug Ford, and Prime Minister Justin Trudeau.
